## MAQUOKETA VALLEY RURAL ELECTRIC COOPERATIVE

## 2021 ANNUAL MEETING OF MEMBERS

The Annual Meeting of the Members of Maquoketa Valley Rural Electric Cooperative was held at the Berndes Center in Monticello, Iowa at 12:30 P.M. on the 19<sup>th</sup> day of August, 2021.

The meeting was opened with the playing of the National Anthem and a slide show by Touchstone Energy.

President Thielen, having confirmed a quorum was present, called the meeting to order and offered welcoming remarks. He introduced the current members of the Board of Directors, the CEO, employees, and special guests in attendance.

President Thielen then appointed attorney Phil Brooks as Parliamentarian for the meeting. Assistant Secretary Charles McCullough took the official minutes.

President Thielen indicated a roll call of the members was in order unless waived. A motion was duly made, seconded and carried, to waive the reading of the roll of the membership. The members listed in Attachment A had been previously checked against the records of the Cooperative and were present.

The official notice of the meeting was mailed to all members of record on August 2, 2021. A motion was duly made, seconded and carried, to waive the reading of the notice of the meeting.

President Thielen reviewed how members were able to participate in the 2021 Annual Meeting. They could vote in person at the Annual Meeting or they could vote via mail-in ballot, but not both. For mail-in ballots to be counted they were required to be returned to the Cooperative's Anamosa office prior to 12:00 on August 17<sup>th</sup>. The counting of mail-in ballots was completed by three members who were appointed as tellers by Secretary Manternach and overseen by Attorney Brooks.

The minutes of the 2020 Annual Meeting were published in the Annual Report given to each attending member as they registered. A motion was duly made, seconded and carried, to waive the reading of the minutes of the Annual Meeting of the Members held August 18, 2020.

President Thielen then asked if there were any corrections or additions to the minutes. Seeing none, a motion was duly made, seconded and carried, to approve the minutes as written. The President then ordered the minutes to be filed in the records of the Cooperative.

President Thielen turned the meeting over to CFO Kelly Gibbs for the Treasurer's report. She reviewed the financial information that was provided to the members in the Annual Report.

CFO Gibbs then offered to meet with anyone having questions regarding the financial affairs of the Cooperative.

President Thielen then asked for approval of the Treasurer's report. A motion was duly made, seconded and carried to approve the Treasurer's report and the President then ordered the report to be filed in the records of the Cooperative.

President Thielen stated that the next order of business was the election of three (3) directors for a term of three (3) years each.

President Thielen reviewed the responsibilities of the Board and the nominating process that was followed. All members were notified through the Watts Current newsletter and the Cooperative's social media platforms of the upcoming election and the process for seeking a position on the Board.

President Thielen stated that in accordance with the Cooperative's Articles of Incorporation and Bylaws, the Board of Directors had appointed an independent Nominating Committee consisting of the following three members of the Cooperative:

Mr. Allen Monaghan from Delaware County, chairman

Mr. Shawn Staner from Dubuque County, and

Mr. David Aschbrenner from Jones County

The Report of the Nominating Committee was presented, nominating the following members for Directors.

- Jan Null for Region 1, including Jones, Cedar, and Linn Counties
- Charles McCullough and John Murphy for Region 3, Dubuque County
- Larry Swanson for Region 4 including Delaware, Buchanan and Clayton Counties

No petitions were received from members asking to be included on the ballot.

President Thielen indicated that since we had a contested election for Region 3, each candidate would be given 3 minutes to address the membership. Their resumes were also posted in various locations throughout the meeting room.

Charles McCullough spoke first, followed by John Murphy.

President Thielen then asked the membership to complete the ballot they received upon registering for the meeting. The ballots were collected by staff and presented to tellers appointed by Vice President Stewart for tabulation. Vice President Stewart, Attorney Brooks, and the three appointed tellers left the meeting to count the ballots. The results were

combined with the mail in ballots that were returned to the Cooperative prior to the 12:00 August 17<sup>th</sup> deadline.

President Thielen then asked CEO Jeremy Richert to give the CEO's report while the ballots were being counted. Richert reported on the impact the COVID-19 pandemic had on the Cooperative and the adjustments made to maintain services to the Cooperative membership throughout the pandemic. He also detailed the August 2020 Derecho storm that resulted in significant damage to the Cooperative's facilities. The Derecho storm was the largest weather related outage event the Cooperative had experienced in over 30 years. He then provided and update on the reliability and affordability of services offered by the Cooperative. The Cooperative's rates over the prior 12 months were 1.7% lower than what they were in 2012 and overall reliability not including major event days were 32% lower in 2020 than the average lowa utility in rural areas.

CEO Richert then updated the membership on the Smart Grid Project and MVlink. Richert reported that construction of the initial fiber buildout was nearing completion with 2,215 miles constructed since November of 2016. Total signups for internet and telephone services were at 5,413. Richert also reported that data was being collected from substations, meters, and downline equipment across 97% of the Cooperative's distribution system.

Upon completion of the CEO Report, President Thielen indicated the tellers had completed their count of the ballots for directors and the following individuals were elected to three year terms:

- Jan Null for Region 1
- Charles McCullough for Region 3
- Larry Swanson for Region 4

President Thielen congratulated the winners and thanked Mr. Murphy for running.

President Thielen reminded the membership that any request for a recount would need to be made before the meeting was adjourned.

President Thielen called for any unfinished business to be brought before the meeting at this time. No unfinished business was raised.

President Thielen asked if there was any new business the members wanted to address. No new business was presented.

President Thielen asked Patty Manuel, Director of Public Relations, to join him on the stage. He recognized Patty's upcoming retirement and thanked her for her 43 years of service to the Maquoketa Valley membership. The members in attendance thanked Patty with a round of applause.

Having concluded all the necessary business to come before the membership, a motion was duly made, seconded and approved to adjourn the meeting.

The Board of Directors left the meeting to conduct a reorganizational meeting in accordance with the Cooperative's Articles and By Laws.
